2020 Minutes

Motion to accept last year's minutes (2020). Proposed by Joshua Emmitt, seconded by Olivier Rochecouste. Passed unanimously.

Reports

The following reports were tabled at the AGM.

Chair's Report

Thinking about the goal of CAA Australasia in 2021. Digital archaeology is ubiquitous, a very different scenario to when CAA International was founded. With that in mind, the goal of CAA Australasia should be to promote the work of archaeologists using digital technologies in our region - making sure we are not forgotten and overlooked by the rest of the world.

It should also aim to promote and support the work of our First Nations colleagues.

The Journal of Computer Applications in Archaeology is being added to SCOPUS.

2020 was a great year (ironically) for CAA Australasia. Online conference was a huge success, 100 people at any one time, with over 30 countries represented. Special thanks to Aleks Michalewicz for stepping in at the last minute and organising access to University of Melbourne's Zoom Conference license to host the conference.

Motion to accept the Chair's Report moved Aleks Michalewicz, seconded by Simon Wyatt-Spratt, passed unanimously.

Treasurer's Report

Aleks Michalewicz tabled the Treasurer's Report, for the period of 1 Jan 2020 to 31 Dec 2020, which can be accessed <u>here</u>.

CAA Australasia currently has \$26,500.14 in its accounts.

Summer Institute was the primary credit, the major expense was gifts and payment for our keynote speaker Simon Holdaway, Gerard O'Regan and the Welcome to Country for the conference.

Motion to accept the Treasurer's Report moved by Joshua Emmitt and seconded by Melanie Ward. Passed unanimously.

Membership Secretary's Report

Josh Emmitt tabled the Membership Secretary's Report on behalf of Andrew Wilkinson, who stepped down in mid-2020.

Updating the membership system is a priority for 2021, with creation of a new, more accessible membership list. We are currently sitting at approximately 94 members, which is slightly down from the previous year.

Establishment of temporary conference coordinator role:

Katherine Thomas moved that a temporary committee position be created, that of Conference Coordinator. This position will act as a permanent liaison with Auckland University in order to ensure continuity on the committee in regards to the proposed CAA International Conference to be held in Auckland. Once elected the person will hold this position permanently for three years, unless voted out by a unanimous vote of the remainder of the CAA Australasia Committee. After the conference is held the position will cease to exist.

Conference Update

The conference proposal for Auckland 2024 is progressing well. The official proposal to put to CAA International is completed. Initial sponsorship has already been obtained from a number of companies.

A successful conference will help fund CAA Australasia for another 10 years, as the initial conference in Perth did.

The first time in the Pacific, the second time in Australasia, and the second time in the southern hemisphere.

If the bid is successful, we'll need to appoint additional, temporary, members to the committee to help with the administrative work.

Summer Institute book update

One of the editors, Olivier Rochecouste, provided an update on progress with the book resulting from the CAA Australasia Summer Institute. A contract has been agreed to in principle with Sydney University Press and is waiting to be finalised and signed. The proposed title is Australasian perspectives in digital archaeology.

Drafts of the chapters are due from the authors by the end of June.
